- 1. Call to Order. Introductions
 - a. The meeting of the Executive Committee of the PA Chapter of the American Planning Association was called to order at 11:02 AM on September 20, 2013 by President Brian O'Leary.
- **2.** Treasurer's Report
 - a. Pam Shellenberger reviewed the financial statements.
- **3.** Chapter President Report.
 - Marketing efforts for the Chapter: Reviewed draft flyer and discussed goals of producing flyer
 - Flyer will raise profile of planners and the chapter;
 - Flyer will be distributed to local municipalities and PMPEI;
 - Update the flyer with newer plans and implementations;
 - Remove the dates from the flyer;
 - Have the flyer drive people to the website for examples;
 - Flyer Titles: Need a Community Planner; Value of a Community Planner;
 - Marketing flyer will need budget money allocated for mailing, printing and graphic artist;
 - State Planning Board
 - Letter went out, no response to date.
 - Great Places Initiative
 - Pam Shellenberger reviewed North Carolina and New Jersey Great Places Initiative program
 - North Carolina's budget of \$10,000 (some of the funds were from a grant); the money was used on communications, section involvement; and TV communications; media.
 - New Jersey's budget was \$500. The money was used on email communication. New Jersey received over 50 applications via email
 - Both states had a committee to review applications
 - Great Places Initiative helped make public aware of planning in their communities
 - Need a committee from the membership to take on this project
 - Review budget and allocate funds for the costs, plans and criteria to launch *Great Place Initiative* in Pennsylvania
 - Spring 2015, but we would need start planning for 2014
 - Announcing Election Results; informing candidates
 - Teller committee will review votes and decide on how to let the candidates know about the results of the election. Results will be shared before the conference.
- 4. Budget
 - a. Susan Shermer and Pam Shellenberger gave a brief overview

- Chapter only dues close to 25k; membership stable
- Conference is seeing slight increase sponsorships, registrations at this point (still below budget);
- Pitkin scholarship is not heavily supported; need to share this information with membership
- Advertising is declining
- Newsletter budget needs to be revisited on whether to continue print or not
- Section support will be different this upcoming year.
- Discuss conference program at board meeting
- Need to incorporate funds for great places initiative
- Need to incorporate funds for marketing piece

- c. Student Representative: The board reviewed applications for student representatives. A motion to select Ellen Hwang to be the next student representative was made by James Cowhey and seconded by Pam Shellenberger. The motion carried.
- d. Jerry Walls and Irv Hand
 - A motion to approve the following people (see below) for scholarships was made by James Cowhey and seconded by Tina Roseberry; the motion carried.
 - Nicole Hostettler will receive \$975 from the Jerry Walls Scholarship
 - Amy Miller will receive \$2500 the Irving Hand Scholarship
 - Debaleena Majumdar will receive \$1025 from the Jerry Walls Scholarship with the following stipulations: must be present at the conference; can't use funds for travel; funds must be used for publishing; must study in the Pittsburgh area
- e. Planning and Community Health Project

 - Possible Topics for the next training: green infrastructure, economic redevelopment and urban planning
- g. Strategic Planning 2015
 - Retreat will need to be planned for 2014 for strategic planning in 2015; a budget will need to be put aside for this retreat; a facilitator may be needed (Board has not decided)
