M. Powell Lawton



M. Powell Lawton was a behavioral psychologist and international authority on aging. He was a major force in shaping national public policy to enhance quality of life for the elderly.

Dr. Lawton's groundbreaking research, writings and teachings on the physical, psychological, environmental and social aspects of aging garnered numerous awards and grants from governmental agencies and private foundations. He was the first to recognize the importance of designing living environments for the elderly, particularly those with Alzheimer's disease.

During his prolific career, Dr. Lawton was a member of the Philadelphia Geriatric Center (PGC) research team for nearly 40 years and its first director. At his death, he was senior research scientist and director emeritus of PGC's Polisher Research Institute.

Neville Strumpf was founding director of the University of Pennsylvania's Hartford Center of Geriatric Nursing Excellence and for many years was Director of the Gerontology Nurse Practitioner Program at the University of Pennsylvania. During her active

career, she was heavily engaged in research focused on the problems of frail elders in hospitals and nursing homes, in particular the overuse of physical restraints. Other research interests included falls and end-of-life care. She was the recipient of many research grants from the NIH, as well as foundations, authored more than 100 articles, book chapters, and books, and was nationally and internationally recognized for her work with older adults. Since retiring from Penn, she continues to consult and is also actively engaged in numerous community based initiatives related to the aging, including President of the Board of Directors of the Ralston Center, member of the Board of Directors at Foulkeways, and a volunteer consultant for Communi-care, a service of the Community Outreach Partnership; Friends in the City; and Penn's Village Advisory Council.
