

## Blair County

- Population 127,089 as of 2010 Census
- 25 Municipalities
  - 1 City, 9 Boroughs and 15 Townships
- Urban Core vs. Rural/Morrison's Cove



#### Blair County Planning Commission

- No countywide Subdivision and Land Development Ordinance
- No regulatory powers concerning land development
- Advisory in nature and can only make recommendations
- Difficult to ensure that developments provide sidewalks and proper walkability
- Development approvals decided by municipal officials
  - Not all municipal leaders seem to be concerned with walkability

#### Sidewalk Ordinances

- Blair County Municipalities with Sidewalk Ordinances
- 17 municipalities have some form of Sidewalk Ordinance
- 8 municipalities do not have any reference to sidewalk requirements

#### Sidewalk Ordinances, continued

- Not all municipalities have sidewalk ordinances
- Even if a municipality has a sidewalk ordinance, it may not be enforced
- Not all land uses require sidewalks
- Ordinance language is sometimes worded to allow waivers/variances for omitting sidewalks or to leave the decision up to municipal officials to determine sidewalk need
- Altoona very strict with sidewalk requirements and rarely allows waivers

### What can we do?

#### • County review process

Sometimes successful when suggesting inclusion of sidewalks and walkability measures

#### • Municipal outreach

- Explain benefits of sidewalks and walkability
- Provide information on funding opportunities for pedestrian infrastructure
- Engage public and special interest groups
  - Voice concerns to municipal leaders over lack of pedestrian infrastructure and desires for increased walkability
- Ensure future planning calls for the inclusion of adequate pedestrian infrastructure

## PA WalkWorks Program

- Successes
  - Three routes within City of Altoona
  - Handful of walkers and groups utilizing the routes
  - Many citizens expressing interest in the program
  - Have already started planning for future WalkWorks communities and routes
- Obstacles
  - Routes currently located only within Altoona, excludes rural and distant citizens
  - While interest is high, public has been slow to actively adopt the program
  - Municipal concerns over liability
