The training will be led by Michelle Brummer, AICP, Project Manager and Environmental Planner with Gannett Fleming. Michelle conducts community, transportation and environmental planning studies and facilitates public involvement activities for Gannett Fleming's clients. Her resume includes municipal comprehensive and recreation and open space plans, long-range transportation plans, byway management plans, and strategic plans as well as highway and transit design projects. She is responsible for conducting Community Health Needs Assessments and developing Community Health Improvement Plans for the Health System. Ms. Yoder was the Principle Investigator for the CDC's Community Transformation Grant which fostered community health improvement efforts around policy and the built environment... Making the Healthy Choice, the easy choice.

Alice worked with a variety of community partners over the years to develop programs that met unmet needs; some include the Child Advocacy Center (for children victims of sexual assault), Project Access Lancaster County (voluntary medical care for people who are low income / underinsured), Dental Access Lancaster County (voluntary dental care for people who are low income / underinsured), and Sexual Assault Forensic Examining Program, to name a few. In addition, she has been a founding member of coalitions such as the Lancaster Health Improvement Partnership, Lancaster Coalition Against Domestic Violence, Lancaster County Lead Coalition, Lighten Up Lancaster County (obesity) Coalition, the Hunger-free Lancaster County, and most recently, Let's Talk, Lancaster (mental health).

Alice has served on national, state, and regional advisory boards and presented at conferences on topics related to the development, sustainability, and measurement of community health improvement initiatives that address various health related issues in our community.

Alice serves on the Lancaster County Planning Commission, West Hempfield Planning Commission, the Governor's Advisory Board on Health, and the Governor's Health Innovation Population Health Task Force.
