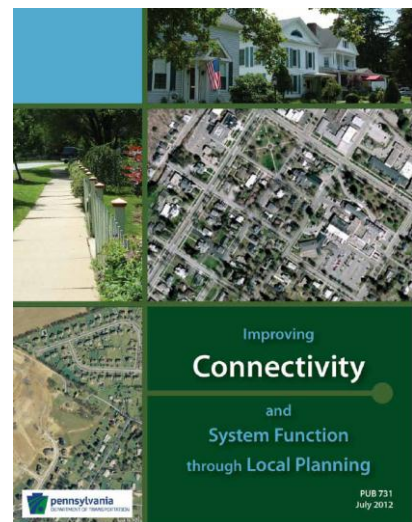

Steve Deck, AICP

Steve Deck has 29 years of experience in transportation planning and policy, all levels of NEPA analyses, and a wide range of municipal planning efforts. He has been responsible for the oversight of planning analyses for a variety of types of projects and has extensive expertise in the area of community/public involvement. He has provided training in the areas of transportation impact fees, secondary and cumulative impact analyses, comprehensive and regional planning, the transportation project development process, and planning implementation tools. He also serves on a municipal planning commission, providing him with an understanding of local planning issues and procedures. He currently acts as the office manager for Parsons Brinckerhoff's Harrisburg, PA office and manages the PennDOT Planning Services and Implementation and Aviation/Rail Freight open-end contracts.

Brian Funkhouser, AICP

Brian Funkhouser has over 20 years of transportation planning experience in both the public and private sector. In addition to his MPO experience with the Harrisburg Area Transportation Study (HATS), he has worked for almost a decade with the private consulting firm of Gannett Fleming in Camp Hill. Brian also works with community planners on the development of transportation elements of county and municipal comprehensive plans. Brian has also served his community as a borough council member and chairman of his local planning commission in Bloomfield Borough, Perry County.

She was the Zoning Administrator for the City of Harrisburg prior to being employed with PennDOT, and currently serves on the City's Zoning Hearing Board.
